This data shows that: between 2004 and 2018, the employment rate increased in every ethnic group; the biggest increases were in the combined Pakistani and Bangladeshi ethnic group, where the employment rate went up from 44% to 57% (up by 13 percentage points) and the Other White ethnic group, where the rate went up from 71% to 82% (up by 11 percentage points)
